 - a. Bank Account at \$5,590.
 - b. Anderson & Whitney Meeting If we wanted to continue as a 501c3 we would need to pay about \$600 in reinstatement fees. It would be about \$4600 for Anderson & Whitney to assist with getting MVSC compliant again. Anderson & Whitney suggested that we file as a non-profit corporation and file a corporate tax return each year. If we do make a profit, we would have to pay corporate taxes. For example, last year we had \$2,593 in income and \$2,492 in expenses so we would pay corporate tax on \$111 profit.

< Motion> - Not renew 501c3 status and file as a non-profit corporation. Motion seconded and 8 in favor, 0 not in favor.

Action – Lindsey will contact the IRS to see what will be needed to transfer MVSC to a non-profit corporation and if MVSC will need to file back years.

Action – Carlos to speak to the Ice Haus about a filing cabinet for the club paperwork. Justin has a cabinet he can donate if we can place one at the Ice Haus.
