Meeting Minutes

July 14, 2020

1. **President Report**

Still waiting on the Ice Haus to reopen. No word yet on when they will be reopening. Will keep everyone updated once we have any updates.

2. **Financial Update**

Currently, MVSC has:

- Main Bank Account - \$3,064.53
- Performance Squad - \$4.
- Tax Returns – Have enlisted HR Block to get the last two (2) years of tax reporting completed. Cost would be \$300 to get it done. HR Block will file the last two (2) years of tax returns for MVSC for the period of 2018 – 2019 and 2019 – 2020. They will also ask for “forgiveness” from the IRS for late filing. Going forward, MVSC will be able to fill out a post card annually if we bring in less than \$5,000 in revenue per year.
- **ACTION** – Need to vote on MVSC spending \$300 to pay HR Block to complete MVSC tax return. Lindsey to provide history for new MVSC members so that they can review and submit their vote within one (1) week. Members will need to vote on:
 - **Move Forward with HR Block**
 - **Research someone else to complete the tax returns to see if we could get it done for less than \$300**

3. **Committee Updates**

A. Fund Raising

- i. Cook Book – MVSC would provide a cookbook of about 75 – 100 recipes for the cookbook. If we sell 50 of them at \$12 per book, we would pay for the cost of printing the book and make about \$750 - \$800. MVSC will put the information in the MVSC newsletter regarding submitting recipes and getting the presale done. Also, MVSC will hold an art contest for the skaters to provide art work for the cover and divider pages.
- ii. MVSC Calendar to be sold during the holiday season for 2021 calendar year.
- iii. Professional photo shoot during the Holiday and Spring Ice Shows

B. Membership

- i. We have about 15 members signed up as of 7/14/20. Melayna will send a reminder to members to renew before the membership renewal period ends August 31st. During that reminder email, Melayna will include announcements regarding upcoming sessions listed below in item ii.
- ii. Membership Initiatives / Mini Camps:
 - i. Off Ice with Carla Villavicencio – Per a previous vote, MVSC will pay Carla \$150 for four (4), 45 min. off ice training sessions for up to 20 skaters. Training sessions will be held July 27th through July 30th from 5:30 pm – 6:15 pm at the Moxi Theater in Greeley.
 - ii. 1 Day Mini Camp with Liz Egtoe – To be held on Saturday, July 25th from 7:30 am –

1:45 pm at NoCo in Windsor. Costs are as follows:

1. Up to 6 skaters - \$400/\$67 per skater (rounded up)
2. 7 - 8 Skaters - \$750/\$94 per skater (rounded up) ** Going to try and get this to \$650**
3. 10 skaters - \$850 (Trying to get this to \$800) \$85 per skater
4. 12 skaters - \$1000/\$84 per skater

MVSC has agreed to pay up to \$400 for this type of camp. The more skaters that we receive the cheaper it will be for members and MVSC.

- iii. On Ice with Kristin Conroy - \$65 per one-hour session/up to 20 MVSC skaters. Would need to pay ice fee of \$195 at Epic / hour in addition to coaching fees for Kristin at Epic (estimated \$8 / session).

4. **NoCo Ice Rink** – Carlos as reached out to the management there to see if MVSC could rent any ice time however he has not heard back and it has been over

5. **New Business**

- A. Fireworks Sports Entertainment/Gracie Gold – Received an email regarding online sessions with Gracie Gold for \$10 / session. Carlos will investigate further.
- B. Aspire Program – Bridge program between MVSC and Ice Haus. Will re-evaluate once the Ice Haus is open again.
